Hours of work may vary from 6:00 a.m. to 2:00 p.m., 2:00 p.m. to 10:00 p.m. and/or 10:00 p.m. to 6:00 a.m. The successful candidates must be available to work weekdays, weekends and statutory holidays, and must be available on short notice for call in shifts.

- Completion of Personal Support Worker Certification program or equivalent
- Excellent interpersonal and communication skills
- Current Criminal Record Check with a Vulnerable Sector Screening that is satisfactory to Strathmere Lodge/County of Middlesex
- Completion of a 2-Step TB test
