

# THE CORPORATION OF THE COUNTY OF MIDDLESEX

## BY-LAW #6874

A BY-LAW to Establish User Fees and Service Charges for Transportation Services.

WHEREAS the Municipal Act, S.O. 2001, Chapter 25, Section 391, states that despite any Act, a municipality and a local board may pass by-laws imposing fees or charges on any class of persons, for services or activities provided or done by or on behalf of it, for costs payable by it for services or activities provided or done by or on behalf of any other municipality or local board; and, for the use of its property including property under its control;

AND WHEREAS the Municipal Act, S.O. 2001, Chapter 25, Section 397, states that a by-law imposing fees or charges passed under this Part by a local board of a municipality which is not a local board of any other municipality shall not come into force until the municipality passes a resolution approving the by-law.


AND WHEREAS it is deemed necessary to charge user fees and service charges for Transportation Services;

NOW THEREFORE the Council of The Corporation of the County of Middlesex hereby enacts as follows:

1. That Council does confirm and ratify the user fees and service charges described in Schedule "A" for Transportation Services attached to and forming part of this By-law;
2. That By-law #6410 is hereby repealed.
